NABH Announcement: Continuous Application Process for the Five-Day Assessors' Training Programme as per NABH 6th Edition Standards for Hospitals

The National Accreditation Board for Hospitals & Healthcare Providers (NABH) is pleased to announce the initiation of a continuous application process for its Five-Day Assessors' Training Programme, aligned with the NABH 6th Edition Standards for Hospitals.

Who are we looking for? The candidate must demonstrate -

Thorough Knowledge of NABH Standards - Demonstrates a deep understanding of the NABH Hospital Accreditation Standards (5th and 6th Editions), including their intent, implementation requirements, and evaluation methodology.

Strong Ethical Integrity - Maintains the highest standards of honesty, objectivity, and impartiality. Avoids conflicts of interest and ensures fairness in all assessment activities.

Analytical and Observational Skills - Possesses the ability to critically analyze systems, identify gaps, and assess compliance through documentation review, staff interviews, and on-site observations.

Effective Communication Skills - Communicates findings clearly, respectfully, and constructively with all levels of hospital staff, both verbally and in written reports.

Professionalism and Confidentiality - Demonstrates professionalism in conduct, appearance, and demeanor. Upholds confidentiality and respects the sensitive nature of healthcare information.

Time Management and Organization - Efficiently plans and conducts assessments within defined timeframes, maintaining thoroughness without compromising timelines.

Team Collaboration - Works collaboratively with co-assessors and hospital personnel, contributing to a positive and productive assessment environment.

Adaptability and Problem-Solving - Adapts to diverse healthcare settings and dynamically addresses unforeseen challenges during the assessment process.

Commitment to Continuous Learning - Engages in ongoing professional development to stay updated with the latest in healthcare quality, patient safety, and accreditation standards.

Report Writing Skills - Prepares clear, concise, and evidence-based assessment reports that accurately reflect the findings and support accreditation decisions.



Applications are invited for eligible candidates as per the following experience and criteria-

Experience for Clinicians:	<p>Post-graduation in a clinical subject (MD/MS/DNB or higher qualification) with minimum of 7 years of experience. Higher qualification in clinical branches will be preferred.</p> <p>Preference will be accorded to candidates working in and nominated by hospitals accredited under the NABH 5th Edition Hospital Accreditation Standards wherein no NABH assessor is currently affiliated.</p>
Experience for Hospital Administrators:	<p>Clinical - MBBS with Post Graduation in Healthcare Management or Hospital Administration with minimum of 10 years of experience.</p> <p>Non-Clinical – Graduation in any discipline with Post Graduate diploma in Hospital/ Healthcare management or Masters in Hospital/ Healthcare Management with minimum of 15 consecutive years of experience in Hospital Operations/ Administration/Quality.</p> <p>In addition to both clinical and non-clinical, all administrator category candidates MUST be currently employed/ working in NABH Accredited Hospitals/ Government Hospitals for last 3 consecutive years and nominated by the Head of the Organization / Managing Director / Chief Executive Officer of the NABH Accredited Hospitals/ Government Hospitals.</p>
Experience for Nursing Officers:	<p>PhD/M.Sc. Nursing with minimum of 7 years of experience</p> <p>or</p> <p>B. Sc. Nursing with minimum of 10 years of experience</p> <p>Preference will be accorded to candidates working in and nominated by hospitals accredited under the NABH 5th Edition Hospital Accreditation Standards wherein no NABH assessor is currently affiliated.</p>
Additional Essential Criteria – Attending 3 days Programme on Implementation (POI) training course on NABH 5 th or 6 th Edition Hospital Standards conducted by NABH.	

Course details and fee:

The training programme is of **five days duration**, conducted in in-person **onsite mode**, and requires full attendance on all five days. The course includes **interactive teaching sessions, practical exercises**, and a **final written examination**.

Participants will be **evaluated continuously**, and only those who **successfully complete the course and pass the assessment** will be considered for empanelment as NABH assessors.

As part of the selection process, NABH will conduct **interviews with shortlisted applicants** to assess their suitability for the programme. Final selection will be based on the outcome of these interviews. The **date of commencement of the course** will be communicated to the selected candidates in due course.

Course Fee: ₹25,000 + GST @ 18% (*The fee includes the NABH standards and training material*)

Note: Payment is required **only after final shortlisting**, through the "Pay Now" option under the *Training & Education* tab on the NABH portal.

Additional Information:

- The Administrator/ Clinician/ Nurse involved in the Quality Team with active implementation of quality standards only should be nominated. The total number of candidates is anticipated to comprise an equal distribution of administrators, clinicians, and nurses.
- Mere eligibility and applying for Assessor Course or nomination by the organization does not guarantee selection.
- Association with any other accreditation body will lead to disqualification of the applicant.
- The above criteria may be supplemented with additional qualification(s), experience and skill(s) as per NABH requirements.
- NABH reserves the rights of selecting participants as per its operational requirements eg. give preference to the candidate from underserved and remote areas. It is sole NABH Secretariat's discretion to select or reject the candidate as per the operational requirements of NABH.
- The participants who could not qualify the post training examination in the previous courses may reapply.
- NABH will conduct interviews of the candidates before final selection.
- NABH reserves the rights to alter any aspect of Assessor training course without prior intimation to applicants or participants.
- Completion of the course does not mean automatic empanelment by NABH & empanelment of successful participants would be done as per the applicable guidelines of NABH.
- NABH reserves the right to postpone/cancel/defer the event wholly or in part in case of an insufficient number of participants, organizational reasons, changes of availability of faculty or other unforeseeable circumstances.
- In case of cancellation/postponement participants may not assert any claims and any such claims shall be excluded.
- Canvassing in any form may lead to automatic disqualification of the application without further correspondence.
- **Decision of AMC-NABH for the selection of the application will be final and appeal will not be accepted from the candidates.**
- **Candidates who are not shortlisted will not receive any further communication.**
- Submission of false/misleading information at any stage may lead to rejection of the application.
- There are limited seats (approximately 50 selected participants) for each training course. NABH Secretariat will maintain a repository of all the applicants for the purpose of considering the eligible candidates for future programs.
