No new or renewal application will be accepted as per 1<sup>st</sup> Edition Standard after 30th June, 2024 (Please refer S. No.1, 6 and 7). Also, no Surveillance Assessment will be conducted as per 1<sup>st</sup> Edition standards after 1<sup>st</sup> October 2024.
