**REVISION OF FEE STRUCTURE FOR DIGITAL HEALTH ACCREDITATION PROGRAM w.e.f. 1st MARCH, 2025**

Dear Colleagues from NABH Accredited HCOs & SHCOs ,

Digital Technology has played a crucial role in supporting the healthcare sector, offering innovative solutions in managing patients, and facilities. The adoption and implementation of digital health is a significant stride that can be instrumental in effectively addressing various challenges and improving accessibility, efficiency, and affordability of healthcare services.

Given the importance of Digital Health, NABH has drafted India's first-ever Digital Health Standards for Hospitals to enable the adoption of digital health processes and ensure safe & secure use of digital health solutions. The 1st Edition of NABH Digital Health Standards for Hospitals was released on 17th September 2023 during the NABH Patient Safety Conference 2023.

Furthermore, based on the feedback from the industry with respect to the visible benefits realized from the adoption of Digital health standards and subsequent careful consideration, NABH has decided to revise the fee structure for the Digital Health Accreditation Programme for HCOs and SHCOs so that the healthcare industry at large could benefit.
